

Dear Members of the Fair and Just Parole Board,

Thank you for allowing me the opportunity to share my thoughts regarding the potential early release of Andrew Kramer. My answer, without hesitation, is a resounding *no*. Please do not release him from prison early.

Andrew Kramer committed some of the most violent and heinous crimes imaginable against my family and me. There were 26 documented attacks, ranging from relentless stalking to cold-blooded attempts on our lives. His actions left deep physical, emotional, and financial scars that continue to affect us to this day.

While I am unsure of what specific information the parole board has in its possession, I want to state some crucial facts about Kramer's case. He secured a "sweetheart" plea deal, which omitted the attempted murder charges, allowing him to avoid the full weight of accountability for his actions. This deal came after years of Kramer using his wealth to manipulate the legal system—first by dragging out civil litigation against my family, and then by exploiting legal loopholes during his criminal sentencing and restitution hearings.

Throughout this entire ordeal, Kramer has shown zero remorse for his actions. While I've read that he supposedly expressed regret for his drug trafficking activities, never once has he apologized to my family for the terror and devastation he inflicted upon us. There has been no acknowledgment, no apology—nothing to suggest that Kramer feels any guilt or responsibility for his relentless campaign of violence and intimidation.

On January 30, 2012, Kramer hired four hitmen to murder my mother and me in our own home. By the grace of God, I am able to write this letter today, but the events of that night will haunt me forever. I watched in horror as my mother was brutally beaten, struck in the head with a crowbar on Kramer's orders. The only reason we survived is because a friend staying with me that night scared the attackers away. Thanks to the exceptional work of the Beverly Hills Police Department, one of the men responsible, Howard Offley, was apprehended. Yet, this is only a small piece of the justice we've sought.

Kramer still owes my family over \$2,000,000 in restitution—a debt that remains unpaid. His attacks not only shattered our lives emotionally but financially ruined us as well.

As a peaceful man, I am grateful to be alive today, but I still carry the heavy burden of trauma caused by Kramer. I have worked hard to rebuild my life. I am sober. I am a father to a beautiful three-year-old boy, Zion, and I have a daughter on the way. However, I live with the fear of how I can protect my family when Kramer is eventually released. I am deeply concerned that his early release is even being considered, given the magnitude of his crimes and his complete lack of remorse. If he hadn't had access to vast sums of drug

money to fund his defense, justice might have been served sooner, and my family would have had some measure of peace.

Kramer is a monster. A genuine danger to society—and especially to my family.

My mother is now, for lack of a better term, brain-dead. She resides in an assisted living facility, completely incapacitated by the traumatic brain injury she suffered at the hands of the hitmen Kramer sent to kill us. She was once a vibrant, intelligent woman, full of life and energy. Now, nothing is the same. The brutal violence she endured changed her forever. There are no words to fully capture the extent of the harm Kramer caused her—and to see her in this condition is a constant reminder of his cruelty.

I hold no grudges, and I harbor no resentment. I am a man of faith, and I believe in karma and the afterlife. But I write this letter to make it clear to the parole board just how devastating Kramer's actions have been. He orchestrated a years-long campaign of terror against my family, and to this day, he has never once taken responsibility for his crimes. He has not paid the restitution owed to us, and my family remains financially destitute as a result. The damage he caused was not just physical—it was emotional, psychological, and financial.

I implore the parole board to deny Andrew Harrison Kramer's early release. He is a dangerous, unrepentant criminal who should not be allowed back into society. I know California law allows for early release in certain cases, but I pray this is not one of them. The man who tried to destroy my family should remain behind bars, where he belongs. Thank you for your time and consideration.
