Dear Congressman Schiff,

I'm writing this letter as my last hope to appeal to you for help. In the past years my family and I have fought off a criminal gang, who has destroyed my family with terror, attempted murder, arson, car bombing and several home invasions and now the final blow of losing our home. As a result our quality of life for the last several years have been horrific, we have lived under house arrest with the constant threat of death.

I've tried many times with the aid of attorney, consultants and other professional people to help modify our loan with Country Wide, Bank of America, Bank of New York, Mellon and Green Tree. We had several conversations with the managers and no help. They have never heard of such a demise that we've experienced and survived. Instead of helping us, they swept our case under the carpet and sold the note to other institutions. Our home was burned to the ground by these criminal activities. The property was forced insured by the banks. There are clauses in the insurance to help rebuild our home, but the banks refused to work with me, knowing I can pay my obligation and resolve the situation.

My daughters and I have been totally demised and we were in fear for our lives. The first felony charge was stalking to see us separate then attack us. Being handicapped, recovering from multiple surgeries and a senior this has taken years off my life.



Ms. Renee Meckler Rose has demonstrated in a letter to all parties, that there is money available to us to pay our obligation. As well as victim's rights programs which we qualify for help.

The foreclosure is scheduled for 9/2/14, Mr. Congressman Schiff, Please help, I ask you to write a letter on my behalf to stop the foreclosure, postpone the procedure and allow a mediator to help resolve the loan with the bank and help us rebuild our lives. Please help, I'm hanging on the cliff with a broken fingernail . I'll make myself available at any time.

I want to thank Ms. Vuna, Ms. Andrade, Ms. Renee Meckler Rose and the Police agencies who have been incredible in helping us.
