Dear Governor Newsom,

My name is Justin Lanning.

I have met evil and its' name is Andrew Harrison Kramer. (Case No. BA410217)

I was tortured by 4 men who entered my home on January 30th 2012, armed with a crow bar to kill my mother and I, at the behest of Kramer.

My nose was severely broken, after a painful surgery and more recommended, I have decided to live with my nose. My neck and vertebrae damaged from one of Howard Offley's thugs breaking my neck and cracking my bones.

I was beaten and tortured, forced to feel helpless, while I watched the most important person in my life being taken away from me, my helpless mother, who was only a few feet away from me, covered in a pool of her own blood.

There was nothing I could do. My mother was easily restrained by one of the murderers, while the other three overwhelmed me.

My mother suffered a severe traumatic brain injury. She was hit in the head repeatedly by a crow bar. I was forced to watch.

She will never be the same. She has changed dramatically and is no longer able to remember things. She has no recollection of that night, whatsoever.

I do.

It is indelibly etched into my consciousness. I wake up screaming, reliving the nightmare. I cry. I thank God. He spared our lives.

Only because of His Divine Intervention am I permitted to even write this prayer.

I will answer a question for you that someone who faces death can answer.

"Is there a God?"

He spared our lives. It was in a moment of total acceptance of impending doom and horror that I spoke to Father in my heart. I said, "God, I can't believe this is how I am going to die, but thank you for allowing me to die with my mother."

In that moment, a homeless drunk who goes by the alias of Shadow, scared the murderers and created a distraction that put his own life at risk and it worked.

Kramer will be eligible for parole in 2032. I pray that Kramer faces the totality of his 37.5 year prison sentence at Delano State Prison! Kramer is a danger to all society. Kramer is a monster.

Kramer is a terrorist. Kramer should have life in prison without the possibility of parole.

The justice system and the local and state government failed my family and I.

My family and I were stalked, hunted with multiple attempted murders.

We pleaded with the police to do something! They all stood by and did nothing.

I believe in second chances and I am not one to hold anger. The justice system has failed my family and I. Not only the justice system, but even the prominent City of West Hollywood persecuted and vilified my family and I. The local government actually sided with the notorious criminal and sued my family and I. We were no match for the corrupt city officials who were most likely well paid by Kramer to turn a blind eye.

Howard Offley, the main ringleader of the January 30th 2012 attempted murder, has already been let out of prison, only after serving 5 years.

Offley never once apologized or condemned his behavior and neither cooperated with police about the other 3 men involved in the attempted murder. They were never caught by police. Offley, in his own right, is a vicious and violent criminal. The acts that Offley and the three murderers performed will never be forgotten. The scars will never heal. As one can imagine, I have severe PTSD. After witnessing my mother, bloodied, beaten, unconscious and lifeless, I was then forced to prepare for the afterlife, myself.

Offley and the three other murderers were paid \$10,000.00 each to murder my mother and I in cold blood. I will never forget my mothers favorite white silk pajamas that were drenched in her bright red blood.

Kramer brilliantly manipulated the justice system. Kramer and his battery of attorney's successfully delayed every single court and restitution proceeding, thwarting justice, spanning two decades. The criminal restitution took over 4 years and was in front of 2 different judges, besides the Grand Jury.

Kramer has shown zero remorse.

No amount of criminal restitution could ever rewrite the bloody history. No amount of money can stop the nightmares, or my mother's TBI.

On that note, My family and I were promised by the District Attorneys of Los Angeles, Garrett Dameron and Renee' Rose, that once we were awarded criminal restitution (the second time around, and after it was reduced to about 1/2 of the original amount) that my parents and I would receive \$20.00 or \$30.00 per inmate, per month, per CDCR request for victims services.

We never received one penny from the CDCR. Not only that, but when we were finally told that we needed to put in applications for that to the CDCR by Dameron's assistant, that when the applications were finally answered, the criminals were ALL let out of prison. Except Kramer. We still have yet to receive one penny from the CDCR! Kramer was arrested April 16th, 2013.

After many attempts to DA's, I still have yet to receive judges orders of restitution for the other criminals in the Kramer case of BA410217. Even though this has already been adjudicated and the criminals are already out of the system, for years.

My prayer is that Kramer be denied early release and be denied parole. Please answer our prayer!
